

ORDINANCE NO. 02 – 2023

BOROUGH OF WEST CHESTER

CHESTER COUNTY, PENNSYLVANIA

AN ORDINANCE OF THE BOROUGH OF WEST CHESTER, CHESTER COUNTY, PENNSYLVANIA, AMENDING THE CODE OF THE BOROUGH OF WEST CHESTER, CHAPTER 104, TITLED "VEHICLES AND TRAFFIC," SECTION 104-45 TO ADD A HANDICAPPED PARKING SPACE ON THE NORTH SIDE OF EAST MINER STREET AT 501 EAST MINER STREET, THE WEST SIDE OF SOUTH PENN STREET AT 712 SOUTH PENN STREET AND THE SOUTH SIDE OF WEST MINER STREET AT 120 WEST MINER STREET; AND TO REMOVE HANDICAPPED PARKING SPACES AT 428 WEST CHESTNUT STREET, 703 SOUTH ADAMS STREET AND 349 EAST BIDDLE STREET.

BE IT ENACTED AND ORDAINED, and it is hereby enacted by authority of the Council of the Borough of West Chester, as follows:

SECTION 1. Chapter 104 of the Code of the Borough of West Chester, titled, "Vehicles and Traffic," Section 104-45, titled, "Special purpose parking zones established; parking otherwise prohibited," is hereby amended **TO ADD** the following:

Highway	Side	Location	Authorized Purpose or Vehicle
Miner Street	North	501 East Miner Street	1 parking space for handicapped persons.
Penn Street	West	712 South Penn Street	1 parking space for handicapped persons.
Miner Street	South	120 West Miner Street	1 parking space for handicapped persons.

SECTION 2. Chapter 104 of the Code of the Borough of West Chester, titled, "Vehicles and Traffic," Section 104-45, titled, "Special purpose parking zones established; parking otherwise prohibited," is hereby amended **TO REMOVE** the following:

Highway	Side	Location	Authorized Purpose or Vehicle
Chestnut Street	South	428 West Chestnut Street	1 parking space for handicapped persons.
Adams Street	East	703 South Adams Street	1 parking space for handicapped persons
Biddle Street	North	349 East Biddle Street	1 parking space for handicapped persons.

SECTION 3. SEVERABILITY. If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts hereof. It is hereby declared as the intent of Council of the Borough of West Chester that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included therein.

SECTION 4. REPEALER. All Ordinances or parts of Ordinances conflicting with any provision of this Ordinance are hereby repealed insofar as the same affects this Ordinance.

SECTION 5. EFFECTIVE DATE. This Ordinance shall become effective upon enactment as provided by law.




